- 1. In consideration of the agreement of all other Montgomery County Market Beef Club members, I hereby agree to enter the Cooperative Insurance Plan on my Market Beef calves and pay the rate of \$20 per calf.
- 2. Insurance premium must be paid no later than December Registration date. Insurance will become effective on the day registration payment and a copy of calf purchase receipt are received at the Extension Office. Home Bred & Born does not need purchase receipt unless purchased from local breeder.
- Payment for loss due to death of the Market Beef from any cause will be covered to a maximum payment of 3. **\$1,000** or the original cost of the steer, whichever is less, plus feeding cost of **\$50.00 per month.** The final payment will be to the nearest full month. Salvage meat from any steer loss will be deducted at price per pound (the hanging rail price at the time of the loss).
- 4. Any money remaining in the insurance fund will serve as accumulative reserve. In the event that losses for the year are greater than our funds, claims will be prorated and each claim will receive a proportionate share. All claims submitted to the insurance fund will be settled following the fair, no later than one month from date.
- 5. This insurance will be in the custody of a local bank, approved by the Steer Committee, in the name of the Montgomery County Market Beef Club treasurer, as approved by the County 4-H Staff.
- 6. Market Beef are to be sold at auction at the Montgomery County Fair, unless it appears to the Steer Committee to be advantageous to sell them at some other time and place; in which case, appropriate arrangements will be made.
- Market Beef are not to be disposed of before this Sale date, unless member has the consent of the Steer 7. Committee. Insurance will be terminated on closing day of the Montgomery County Fair.
- Beef breeding animals are not eligible for this insurance, **EXCEPT for Market Heifers registered for the current** 8. year Fair.
- 9. Report claims immediately to: Beef Superintendent or Betty Wingerter at Extension Office 224-9654. Animal must be inspected by a beef superintendent. All claims must be followed up with a written document.
